

## Questions raised by the Participants during pre-bidding meeting of the World Expo 2025

### 1. Is it possible to change the timeline of the Work Schedule or not?

It is stated by the organizer of the World Expo "Japan Association for the 2025 World Exposition" that the work should be completed according to the work schedule.

### 2. Will the Nepal government request the World Expo Organizer for the amendment of construction date & time or not?

The construction work should be done following the work schedule published by the World Expo Organizer "Japan Association for the 2025 World Exposition". On the request of the National Expo Organizer, selected through the competitive bidding process, the designated government agency may request World Expo Organizer regarding the amendment of the construction schedule. The ultimate decision whether to change or not the Construction Date will be solely dependent on the World Expo Organizer.

### 3. What is the basis of the Cost of Participation?

The basis of the cost of Participation is prepared and made available by World Expo Organizer. The details related to the Cost of Participation are also included in the Annex of the Bid Document

### 4. Who takes the responsibility of foreign exchange facility being delayed to it make available for organizer for the development of Nepal Pavilion?

Upon the request of the official National Expo Organizer, Nepal Rastra Bank will be requested from the Ministry of Industry, Commerce and Supply on the recommendation of the Trade and Export Promotion Center, on justified expenses to be required for pavilion development and related works. According to the policy and rules of the Nepal Rastra Bank, the National Expo Organizer will be provided such facility.

### 5. Will Nepal Rastra Bank make available whole the foreign currency to be required for expo expenses at once?


Upon the request of the official National Expo Organizer, Nepal Rastra Bank will be requested from the Ministry of Industry, Commerce and Supply on the recommendation of the Trade and Export Promotion Center, on justified expenses to be required for pavilion development and related works. According to the policy and rules of the Nepal Rastra Bank, the National Expo Organizer will be provided such facility.


### 6. Does an official national organizer of Nepal gets financial assistance from World Expo Organizer or not?

This is mentioned in "Support provided to Nepalese official organizer" under the Terms of Reference of Bid Document.

### 7. How does Trade and Export Promotion Center plan to participate in 20% of the designated Space area?

The utilization of 20% of the designated space area will be solely on the decision of the Government of Nepal.
